CITY RESOLUTION NO. 2023-071

A RESOLUTION ADOPTING THE CITY HISTORY, ARTS, CULTURE AND TOURISM COUNCIL (CHACTC) RESOLUTION NO. 001 S. 2023 ENTITLED "A RESOLUTION ADOPTING THE TOURISM DEVELOPMENT PLAN FOR 2023-2025 OF THE CITY OF MEYCAUAYAN, BULACAN".

WHEREAS, Republic Act No. 9593, otherwise known as the Tourism Act of 2009 declares a national policy for tourism as an engine of investment, employment, growth and national development, and strengthening the Department of Tourism and its attached agencies for effectively and efficiently implement that policy, and appropriating funds thereof;

WHEREAS, Section 16 of the Local Government Code of 1991 states that every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture;

WHEREAS, the City Government of Meycauayan established the Meycauayan City Council for History, Arts, Culture and Tourism and was mandated to prepare the annual plan on History, Arts, Culture and Tourism to be integrated in the local development plan;

WHEREAS, a Tourism Development Plan is a strategic guide to developing tourism sites and organizing resources, with the aim of enhancing tourism's value in an area. For most Local Government Units (LGUs), a Tourism Development Plan defines the Framework to direct the formulation of policies and design of programs to engage the Private Sector, Civil Society Organizations (CSOs), and other LGU agencies to develop a form of tourism that is consistent with the aspirations of the LGU's stakeholders;

WHEREAS, the City History, Arts, Culture and Tourism Council (CHACTC) Resolution No. 001 S. 2023 was approved last June 27, 2023 relative to their Tourism Development Plan;

WHEREAS, the Tourism Development Plan 2023 -2025 will lay down the strategies, actions, plans, programs and activities that must undertake to achieve the goals of tourism.

NOW, THEREFORE, be it **RESOLVED**, as it is hereby **RESOLVED**, that this Sangguniang Panlungsod hereby **ADOPTS A RESOLUTION ADOPTING THE CITY HISTORY, ARTS, CULTURE AND TOURISM COUNCIL (CHACTC) RESOLUTION NO. 001 S. 2023 ENTITLED "A RESOLUTION ADOPTING THE TOURISM DEVELOPMENT PLAN FOR 2023-2025 OF THE CITY OF MEYCAUAYAN, BULACAN"**.


