CITY ORDINANCE NO. 367 (OF 2023)

AN ORDINANCE GRANTING THE RENEWAL OF FRANCHISE TO OPERATE PUBLIC UTILITY TRICYCLE TO THE SEVENTH (7TH) BATCH OF APPLICANTS FOR CALENDAR YEAR 2023, FOR THE ONE HUNDRED THIRTY-FOUR (134) UNITS BELONGING TO ZONE ONE (1) AND ZONE TWO (2).

WHEREAS, Section 458 (a) (3) (vi) of Republic Act No. 7160, otherwise known as the “Local Government Code of 1991” provides that:

“SECTION 458. Powers, Duties, Functions and Compensation. -

(a) The sangguniang panlungsod, as the legislative body of the city, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the city and its inhabitants pursuant to Section 16 of this Code and in the proper exercise of the corporate powers of the city as provided for under Section 22 of this Code, and shall:

xxx

(3) Subject to the provisions of Book II of this Code, enact ordinances granting franchises and authorizing the issuance of permits or licenses, upon such conditions and for such purposes intended to promote the general welfare of the inhabitants of the city and pursuant to this legislative authority shall:

xxx

- (vi) Subject to the guidelines prescribed by the Department of Transportation and Communications, regulate the operation of tricycles and grant franchises for the operation thereof within the territorial jurisdiction of the city.”;

WHEREAS, there is a need to grant the Renewal of Franchise to Operate Public Utility Tricycle as the City of Meycauayan has not reached the ideal number of units based on the Route Measured Capacity (RMC) for tricycle, to eliminate colorum operations and address complaints from local commuters in order to fill the gap on the required public transportation within the City;

WHEREAS, the applicants for the Renewal of Franchise to Operate Public Utility Tricycle have submitted the necessary requirements and their tricycle units has passed the Road Worthiness Inspection in compliance with the provisions set forth in **Chapter III, Article V of CITY ORDINANCE NO. 2012-003** or the *Land Transportation Code of the City of Meycauayan, Bulacan*, as amended;

WHEREAS, the Sangguniang Panlungsod, after final evaluation, finds the **One Hundred Thirty-four (134) Applications for Renewal of Franchise to Operate Public Utility Tricycle** included in the **Seventh (7TH) Batch of Applicants for the Calendar Year 2023 to be in order and necessary for the general welfare of the Citizens of the City of Meycauayan**;

NOW, THEREFORE, be it **ORDAINED**, as it is hereby **ORDAINED**, by the Sangguniang Panlungsod of Meycauayan, Bulacan, in a Regular Session duly assembled, **THAT**:

SECTION 1. The Renewal of Franchise to Operate a Public Utility Tricycle of the following *Operators* are hereby **GRANTED**:

SECTION 2. The Sangguniang Panlungsod, after the review and approval of this Ordinance by the Sangguniang Panlalawigan, shall issue the corresponding Certificate for Renewal of Franchise with their respective Serial Numbers to each Operator enumerated in *SECTION 1*, indicating the Name of the Grantee, the Motor Number, Chassis Number and Plate Number of the Tricycle Unit, the respective Area of Assignment or Zone within the Territorial Jurisdiction of the City, and the Period of Validity of the Franchise.

SECTION 3. The Office of the City Mayor, through the Business Permit and Licensing Office (BPLO), is hereby enjoined to issue the corresponding Motorized Tricycle Operator Permit (MTO) to the Grantees for Renewal of Tricycle Franchise subject to existing laws, rules, and tricycle regulatory ordinances.


SECTION 4. All Ordinances, Issuances, Rules and Regulations of the City which are inconsistent herewith are hereby Repealed and/or Amended accordingly.


