**CITY ORDINANCE NO. 331 (OF 2022)**

***AN ORDINANCE AMENDING SECTION 3 OF CITY ORDINANCE NO. 216 (OF 2019),  
ENTITLED "AN ORDINANCE INCREASING THE RENTAL FEES AND CHARGES FOR THE  
USE OF THE CITY OF MEYCAUAYAN CONVENTION CENTER (CMCC).***

WHEREAS, Section 18 of Republic Act 7160 otherwise known as the Local Government Code of 1991 explicitly grants local government units to:

**"SECTION 18. *Power to Generate and Apply Resources.*** - Local government units shall have the power and authority to establish an organization that shall be responsible for the efficient and effective implementation of their development plans, program objectives and priorities; to create their own sources of revenues and to levy taxes, fees, and charges which shall accrue exclusively for their use and disposition and which shall be retained by them.";

WHEREAS, the City of Meycauayan Convention Center has recently undergone through structural and architectural improvements to provide a safer place, expediency and a better atmosphere to hold events by people or groups who wish to rent;

WHEREAS, upgrades of equipment were also considered and recently acquired for a better entertainment and cooler environment inside the CMCC for the paying guests;

WHEREAS, after a careful review the Sangguniang Panlungsod finds it necessary for the increase of rents and fees in using the CMCC for events to sustain the costs of maintenance and services of the said venue.

NOW, THEREFORE, be it **ORDAINED**, as it is hereby **ORDAINED**, by the Sangguniang Panlungsod of Meycauayan, Bulacan, in a Regular Session duly assembled, **THAT**:

**SECTION 1.** This Ordinance shall be known as, **“AN AMENDMENT TO SECTION 3 OF CITY ORDINANCE NO. 216 (OF 2019), PRESCRIBING NEW RATES OF RENT FOR THE USE OF THE CITY OF MEYCAUAYAN CONVENTION CENTER.”**;

**SECTION 2.** Section 3 of the City Ordinance No. 216 (of 2019) is hereby amended and read as follows:

**SECTION 3. Rates.** - Listed hereunder are the new rates of rent for the use of the City of Meycauayan Convention Center:
