CITY ORDINANCE NO. 332 (OF 2022)

AN ORDINANCE AMENDING LETTERS B, C, & D OF SECTION 2 OF THE CITY ORDINANCE NO. 219 (OF 2019) ENTITLED, "AN ORDINANCE AMENDING SECTION 365 (RENTAL OF CITY CEMETERY LOTS) OF CITY ORDINANCE NO. 2017-031, OTHERWISE KNOWN AS THE REVENUE CODE OF THE CITY GOVERNMENT OF MEYCAUAYAN, BULACAN".

WHEREAS, Section 17 (a) (b) (2) (x) and (4) of RA 7160, otherwise known as the Local Government Code of 1991 expressly provides that:

"SECTION 17. Basic Services and Facilities. - (a) Local government units shall endeavor to be self-reliant and shall continue exercising the powers and discharging the duties and functions currently vested upon them. They shall also discharge the functions and responsibilities of national agencies and offices devolved to them pursuant to this Code. Local government units shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provision of the basic services and facilities enumerated herein.

(b) Such basic services and facilities include, but are not limited to, the following:

(2) For a Municipality

(x) Public Cemetery

XXX

(4) For a City: All the services and facilities of the municipality and province.”;

WHEREAS, the amendment of the City Ordinance No. 2017-031, known as the “Revised Revenue Code of Meycauayan” was approved April 08, 2019 by the Sangguniang Panlungsod of the City of Meycauayan;

WHEREAS, the City Economic Enterprises Management Office finds it necessary for another amendment be made thereon, due to the prevailing costs of materials and services;

WHEREAS, the current fees and charges collected by the City of Meycauayan Public Cemetery are the same since 2017, hence, require increment;

WHEREAS, the Sangguniang Panlungsod has found the said recommendation appropriate and hereby acts thereon to circumvent any confusion in the Section mentioned herein.

NOW, THEREFORE, be it ORDAINED, as it is hereby ORDAINED, by the Sangguniang Panlungsod of Meycauayan, Bulacan, in a Regular Session duly assembled, THAT:

SECTION 1. This Ordinance shall be known as “AN AMENDMENT TO THE CURRENT FEES FOR THE CITY CEMETERY LOTS IN THE CITY OF MEYCAUAYAN.”

SECTION 2. Letters B, C & D of Section 2 of the City Ordinance No. 219 (of 2019) is hereby amended and imposition of fees is as follows:

“SECTION 365. Imposition of Fees. - The following fees shall be collected for each of the corresponding type of cemetery lot, the lease of which shall have a minimum period of FIVE (5) years:

| TYPE OF LOT | RENTAL FEE (Php) |
|--|------------------|
| B. <u>Niche (Apartment Type)</u> | |
| a. Initial 5 years | 15,000.00 |
| b. Succeeding year after initial 5 years, renewable every year | 2,000.00 |


- C. Bone Crypt
 - a. Initial 5 years 1,500.00
 - b. Succeeding year after initial 5 years, renewable every year 500.00
- D. Transfer Fee 1,000.00

SECTION 3. Repealing Clause. - Except otherwise provided herein, any other city ordinance or resolution, which are inconsistent with any of the provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 4. Effectivity Clause. - This Ordinance shall take effect on the day after either its posting in prominent places in the City Hall for a period of three (3) consecutive days or its publication in a newspaper of general circulation, whichever comes later.






