CITY ORDINANCE NO. 333 (OF 2022)

**AN ORDINANCE AMENDING SECTION 4 OF CITY ORDINANCE NO. 221 (OF 2019),
ENTITLED "AN ORDINANCE PRESCRIBING THE FEES AND GUIDELINES FOR THE
PUBLIC CREMATORIUM OF THE CITY OF MEYCAUAYAN, BULACAN".**

WHEREAS, Section 458 (a) (4) (ix) of the local government code provides that:

"SECTION 458. Powers, Duties, Functions and Compensation. - (a) The Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the city and its inhabitants pursuant to Section 16 of this Code and in the proper exercise of the corporate powers of the city as provided for under Section 22 of this Code, and shall:

xxx

- (4) Regulate activities relative to the use of land, buildings and structures within the city in order to promote the general welfare and for said purpose shall:

xxx

- (ix) Regulate the establishment, operation and maintenance of funeral parlors and the burial or cremation of the dead, subject to existing laws, rules and regulations.”;

WHEREAS, by the recommendation of the City Economic Enterprises Management Office there is a need for an increase in charges in the cremation procedure for the improvement of facilities and keep up with the prevailing costs of supplies and services;

WHEREAS, the recommendation from the CEEMO that the amount of fees in the cremation procedure needs increase for the reasons of improvements and persisting expenditures has been found appropriate by the Sangguniang Panlungsod so hereby acts thereon to thwart confusions in the Section mentioned herein.

NOW, THEREFORE, be it ORDAINED, as it is hereby ORDAINED, by the Sangguniang Panlungsod of Meycauayan, Bulacan, in a Regular Session duly assembled, THAT:

SECTION 1. This Ordinance shall be known as “AN AMENDMENT TO THE CURRENT FEE IMPOSED FOR THE CREMATION OF THE DECEASED IN THE CREMATORIUM CODE OF THE CITY OF MEYCAUAYAN.”

SECTION 2. Section 4 of the City Ordinance No. 221 (of 2019) is hereby amended and read as follows:

SECTION 4. Cremation Fees. -

CATEGORY	CREMATION FEE (Php)
Local Resident (11 years old and above)	15,000.00
Local Resident (10 years old and below)	8,000.00
Non-resident of Meycauayan (11 years old and above)	20,000.00
Non-resident of Meycauayan (10 years old and below)	10,000.00
Bone	6,000.00
Cost of URN	1,500.00

SECTION 3. *Repealing Clause.* - Except otherwise provided herein, any other city ordinance or resolution, which are inconsistent with any of the provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 4. *Effectivity Clause.* - This Ordinance shall take effect on the day after either its posting in prominent places in the city hall for a period of three (3) consecutive days or its publication in a newspaper of general circulation, whichever comes later.






