INVITATION TO APPLY FOR ELIGIBILITY AND TO BID

The City Government of Meycauayan, through its Bids and Awards Committee (BAC), invites bids for the following project:

Reference No.: PROJECT G2022-040
Project Name: Purchase of Hemodialysis treatment package for the use of City of Meycauayan Dialysis Center
Location: Saluysoy, City of Meycauayan, Bulacan
Approved Budget for the Contract (ABC): FIVE MILLION PESOS (Php5,000,000.00)
Delivery Period: THIRTY (30) CALENDAR DAYS

Prospective bidders should possess the necessary documents, permits and licenses applicable to the Project, have completed a similar contract with a value of at least 50% of the ABC, and have the required key personnel needed to complete the said project. The BAC shall use the non-discretionary pass or fail criteria during the *Eligibility Check and Screening* as well as the *Preliminary Examination of Bids*. Thereafter, the BAC shall conduct its *Post-Qualification* of the lowest calculated bid wherein the bidder must submit all requirements within FIVE (5) days from receipt of notice as the "Bidder with the Lowest Calculated Bid".

The Eligibility Check and Screening, Bid Security, Performance Security, Pre-Bidding Conference, Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of Republic Act 9184 and its Revised Implementing Rules and Regulation.

The BAC shall only issue *Bidding Documents* upon payment to the Treasurer's Office of the non-refundable amount of FIVE THOUSAND PESOS (P5,000.00).
