**INVITATION TO APPLY FOR ELIGIBILITY AND TO BID**

The City Government of Meycauayan, through its Bids and Awards Committee (BAC), invites contractors registered with and classified by the Philippine Contractors Accreditation Board (PCAB) to apply for eligibility and if found eligible, to bids for the hereunder project:

Project Name: **Furnishing of labor, materials and equipment for the Proposed Road Widening with Drainage Canal at Daungan Road, Malhacan, City of Meycauayan, Bulacan**

Location: **Malhacan, City of Meycauayan, Bulacan**

Approved Budget for the Contract (ABC): **FOUR MILLION FOUR HUNDRED TWENTY THOUSAND SIX HUNDRED SEVENTY-THREE PESOS and 25/100 (P4,420,673.25)**

Delivery Period: **TWO HUNDRED TEN (210 ) WORKING DAYS**

Prospective bidders should possess the necessary documents, permits and licenses applicable to the Project, have completed a similar contract with a value of **at least 50% of the ABC**, and have the required key personnel needed to complete the said project. The BAC shall use the non-discretionary pass or fail criteria during the *Eligibility Check and Screening* as well as the *Preliminary Examination of Bids*. Thereafter, the BAC shall conduct its *Post-Qualification* of the lowest calculated bid wherein the bidder must submit all requirements within **FIVE (5) days** from receipt of notice as the "Bidder with the Lowest Calculated Bid".

The Eligibility Check and Screening, Bid Security, Performance Security, Pre-Bidding Conference, Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of Republic Act 9184 and its Revised Implementing Rules and Regulation.

The BAC shall only issue *Bidding Documents* upon payment to the Treasurer's Office of the non-refundable amount of **FIVE THOUSAND PESOS (P5,000.00)**.
