CITY ORDINANCE NO. 348 (OF 2023)

AN ORDINANCE AMENDING SECTION 4 OF CITY ORDINANCE NO. 2017-005, ALSO KNOWN AS "AN ORDINANCE CREATING THE CITY HEALTH UNITS VIII, IX, X AND XI RELATIVE TO THE STRENGTHENING OF HEALTH SERVICES IN THE ORGANIZATIONAL STRUCTURE AND STAFFING PATTERN IN THE CITY OF MEYCAUAYAN AND FOR OTHER PURPOSES."

WHEREAS, on February 01, 2017, the Sangguniang Panlungsod of Meycauayan approved City Ordinance No. 2017-005 entitled "AN ORDINANCE CREATING THE CITY HEALTH UNITS VIII, IX, X AND XI RELATIVE TO THE STRENGTHENING OF HEALTH SERVICES IN THE ORGANIZATIONAL STRUCTURE AND STAFFING PATTERN IN THE CITY OF MEYCAUAYAN AND FOR OTHER PURPOSES.";

WHEREAS, amending City Ordinance No. 2017-005 is pursuant to the powers. duties and function of the Sangguniang Panlungsod as the legislative body of the City as provided by Section 458 (a) of Republic Act No. 7160, also known as the "Local Government Code of 1991";

WHEREAS, Section 4 of the said City Ordinance states that:

"SECTION 4. Creation of Additional Units under the Office of the City Health. City Health Units VIII (to be located at Barangay Camalig), CHU IX (to be located at Barangay Lawa) CHU X (to be located at Barangay Bahay-Pare) and CHU XI (to be located at Barangay Saluysoy) are hereby created under the Office of the City Health.

CHU VIII shall cater barangays Camalig, Pajo and Pantok, CHU IX shall cater barangays Lawa and Caingin, CHU X shall cater barangays Bahay-Pare and Bagbaguin and CHU XI shall cater barangays Saluysoy, Calvario and Ubihan.";

WHEREAS, during the Committee Hearing held by the respective committees in relation to the City Health Officer's letter request, the amendment shall be in accordance with the order of construction of the aforementioned health facilities and to remove City Health Unit XI due to lack of lot allotted for additional CHU.

NOW, THEREFORE, be it ORDAINED, as it is hereby ORDAINED, by the Sangguniang Panlungsod of Meycauayan, Bulacan, in a Regular Session duly assembled, THAT:

**SECTION 1.** Section 4 of City Ordinance No. 2017-005 is hereby amended and read as follows:

"SECTION 4. Creation of Additional Units under the Office of the City Health. City Health Units VIII (to be located at <u>BARANGAY LAWA</u>), CHU IX (to be located at <u>BARANGAY SALUYSOY</u>) and CHU X (to be located at <u>BARANGAY CAMALIG</u>) are hereby created under the Office of the City Health."

CHU VIII shall cater barangays <u>LAWA and CAINGIN</u>, CHU IX shall cater barangays <u>SALUYSOY and UBIH AN</u>, CHU X shall cater barangays <u>CAMALIG</u>, <u>BAHAY-PARE and PAJO</u>.";

**SECTION 2.** Repealing Clause. Any ordinance, resolution and/or rules and regulations, or any part thereof, which are inconsistent with any of the provisions of this Ordinance are hereby repealed or amended accordingly.

**SECTION 3.** Effectivity Clause. This Ordinance shall take effect immediately upon its approval.
