Prospective bidders should possess the necessary documents, permits and licenses applicable to the Project, have completed a similar contract with a value of at least 50% of the ABC, and have the required key personnel needed to complete the said project. The BAC shall use the non-discretionary pass or fail criteria during the *Eligibility Check and Screening* as well as the *Preliminary Examination of Bids*. Thereafter, the BAC shall conduct its *Post-Qualification* of the lowest calculated bid wherein the bidder must submit all requirements within <u>FIVE (5) days</u> from receipt of notice as the "Bidder with the Lowest Calculated Bid".

The Eligibility Check and Screening, Bid Security, Performance Security, Pre-Bidding Conference, Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of Republic Act 9184 and its Revised Implementing Rules and Regulation.
