INVITATION TO APPLY FOR ELIGIBILITY AND TO BID

The City Government of Meycauayan, through its Bids and Awards Committee (BAC), invites contractors registered with and classified by the Philippine Contractors Accreditation Board (PCAB) to apply for eligibility and if found eligible, to bids for the hereunder project:

Project Name: **Site Development of Housing Units for Relocation of Informal Settlers at Bulac Rd., Malhacan City of Meycauayan, Bulacan**

Location: **Malhacan, City of Meycauayan, Bulacan**

Approved Budget for the Contract (ABC): **FORTY NINE MILLION NINE HUNDRED EIGHTY FOUR THOUSAND SEVEN HUNDRED SEVENTY PESOS and 5/100 (P49,984,770.05)**

Delivery Period: **THREE HUNDRED (300) WORKING DAYS**

Prospective bidders should possess the necessary documents, permits and licenses applicable to the Project, have completed a similar contract with a value of **at least 50% of the ABC**, and have the required key personnel needed to complete the said project. The BAC shall use the non-discretionary pass or fail criteria during the *Eligibility Check and Screening* as well as the *Preliminary Examination of Bids*. Thereafter, the BAC shall conduct its *Post-Qualification* of the lowest calculated bid wherein the bidder must submit all requirements within **FIVE (5) days** from receipt of notice as the "Bidder with the Lowest Calculated Bid".

The Eligibility Check and Screening, Bid Security, Performance Security, Pre-Bidding Conference, Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of Republic Act 9184 and its Revised Implementing Rules and Regulation.

The BAC shall only issue *Bidding Documents* upon payment to the Treasurer's Office of the non-refundable amount of **TWENTY FIVE THOUSAND PESOS (P25,000.00)**.

The City Government of Meycauayan assumes no responsibility of any kind to prospective bidders to compensate or indemnify them for any expenses incurred by them in preparation of their respective bids. It also reserves its right to disqualify and "black-list" any bidders who violate any of the provisions of Republic Act 9184 and its Revised Implementing Rules and Regulation, fail to comply and submit the required documents, submit falsified documents or supply false information, or commit any other fraudulent acts.
