**INVITATION TO APPLY FOR ELIGIBILITY AND TO BID**

The City Government of Meycauayan, through its Bids and Awards Committee (BAC), invites bids for the following project:

Reference No.: **PROJECT G2022-028**

Project Name: **Purchase of Organic Solutions for Dengue Outbreak Control and Waste Treatment to be used in the City of Meycauayan, Bulacan**

Location: **Saluysoy, City of Meycauayan, Bulacan**

Approved Budget for the Contract (ABC): **SIX MILLION FIVE HUNDRED NINETY TWO THOUSAND SIX HUNDRED EIGHTY PESOS (Php6,592,680.00)**

Delivery Period: **THIRTY (30) CALENDAR DAYS**

Prospective bidders should possess the necessary documents, permits and licenses applicable to the Project, have completed a similar contract with a value of **at least 50% of the ABC**, and have the required key personnel needed to complete the said project. The BAC shall use the non-discretionary pass or fail criteria during the *Eligibility Check and Screening* as well as the *Preliminary Examination of Bids*. Thereafter, the BAC shall conduct its *Post-Qualification* of the lowest calculated bid wherein the bidder must submit all requirements within **FIVE (5) days** from receipt of notice as the "Bidder with the Lowest Calculated Bid".

The Eligibility Check and Screening, Bid Security, Performance Security, Pre-Bidding Conference, Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of Republic Act 9184 and its Revised Implementing Rules and Regulation.

The BAC shall only issue *Bidding Documents* upon payment to the Treasurer's Office of the non-refundable amount of **TEN THOUSAND PESOS (P10,000.00)**.
